# **Legislation Watch: FCC Issues Rule for Traceback Requests**

The Federal Communication Commission (FCC) issued "Advanced Methods to Target and Eliminate Unlawful Robocalls, Call Authentication Trust Anchor (47 CFR Parts 0 and 64)," which alters the response time for domestic service providers' traceback requests response time. The new rule went into effect on January 8, 2024, and requires all U.S. domestic voice service providers to respond to any traceback request within 24 hours of receipt.

Citing that rapid traceback is essential to identifying both callers placing illegal calls and the voice service providers that facilitate them, the new rule requires that responses for traceback requests must be fully responded to within 24 hours of receipt of the request. The 24-hour requirement replaces the prior requirement for requests to be responded to "fully and in a timely manner."

The rule applicability is for all traceback requests from the FCC, civil and criminal law enforcement, and the industry traceback consortium, with specifically identifying the 24-hour requirement. The expanded rules are intended to protect consumers from illegal calls, hold service providers responsible for the calls they carry, and aid in the identification of bad actors.

Further, the rule also direct the service providers to block and mitigate illegal traffic when notified by the enforcement bureau.

The request validation procedures performed by the Trust & Safety group have been adjusted to include the FCC and the industry traceback consortium as authorized requestors. Any network mitigation activity remains the responsibilities of the service provider.

## Interview with Kevin Metcalf, Board Member of Raven

### Kevin Metcalf's Biography

Kevin Metcalf is a prosecutor and former federal agent focused on child exploitation prosecution and prevention. He is a board member of Raven and the founder of the National Child Protection Task Force, which consists of experts in legal strategy, dark web, geospatial mapping and analysis, OSINT, cryptocurrency, image geolocation and analysis, and more to aid law enforcement agencies worldwide on cases involving missing, exploited, and trafficked children.



**Tamara:** Would you tell us a little bit about yourself and your background?

**Kevin:** I've been involved in military, federal, state, and local law enforcement for over 30 years. After being on the investigative side for a long time, I went to law school and have been a prosecutor for about 12 years. If you had asked me if I was going to be involved in technology in any way 15 years ago, I would have said it is not going to happen. At the time, I was more focused on counterterrorism, drugs, and other crimes.

When I began my career as a prosecutor, I already had 20 years of experience in law enforcement but no experience in prosecution, which made me the "new guy." So, I was really focused on finding a way to add value and landed on where criminal behavior, technology, and the law intersect. Our legal system and laws are very slow to adapt and address changing technologies for a variety of reasons. From that intersection, I became aware of crimes against children.

If you consider the global reach a large technology company has, predators will have access to that same technology. While we all benefit from this technology, it is also a double-edged sword. For every benefit we receive, there is also a dark side to technology. Too often that dark side runs under the radar, and we don't see the predators talking to our kids when we're driving them into school, on their gaming systems, or while they're on their school's internet.

**Kevin:** When I saw how little attention this issue received, I decided to focus my career on the investigative tradecraft to deal with the cases that were slipping through our fingers. It's not enough to just investigate, we must investigate and prosecute successfully. So, we need to combine investigators with prosecutors to keep them going together. So that has been my main focus of my career.

Tamara: Would you describe the charity, Raven?

**Kevin:** Raven is a 501(c)(4) non-profit charity primarily made up of retired Internet Crimes Against Children (ICAC) commanders. Their mission is focused on obtaining more funding, training, and resources for ICAC units around the United States. Child sexual abuse materials (CSAM) is shared basically forever on the dark web between perpetrators almost as a form of currency, which re-victimizes the child as it was one of the lowest points in their lives.

ICAC, nationwide, only receives \$60 million in funding and that's if it is fully funded. When you start looking at the sheer magnitude of these images and videos and compare that to the amount of funding it receives, you realize it is not nearly enough to protect our children, especially considering other types of criminal investigations have budgets in the billions of dollars. That's where Raven comes in.

Raven reviews bills that incentivize technology companies to act in response to this epidemic.



### **Interview with Kevin Metcalf**

**Kevin:** Raven's CEO, John Pizzuro, spends most of his time speaking to law makers on the national and state levels to encourage these types of laws. Recently, Raven supported a bill that the South Dakota Senate passed into law that will require those convicted of a crime to pay fees for digital examination and would directly fund the South Dakota ICAC.

When people consider a non-profit, they mostly think of 501(c)(3) which is your typical tax-deductible charity, but you're limited on your ability to lobby and speak to lawmakers. As a 501(c)(4), Raven doesn't get the tax benefits, but we are a non-profit lobbyist group, which means we spend most of our time speaking to lawmakers at the state or national level.

Tamara: How did you become involved with Raven?

**Kevin:** Given my background in prosecution and investigations in child exploitation and trafficking, I was asked to join Raven as one of the original founding members. I leverage my expertise in technology and human behavior to review and evaluate upcoming laws and bills and participate in brainstorming on its impact on child sexual exploitation. I add value by reviewing the law as a prosecutor, which is different than as an investigator or policy-maker.

**Tamara:** How could our readers support Raven?

**Kevin:** We're always looking for donations as that's always a struggle for any non-profit. Outside of that, look for ways that you can build awareness on the issue, follow Raven and John Pizzuro on social media, go to the website and look at some of the bills that we're discussing. You can also build support for ICAC units in each state and on a national level. We need people calling their political representatives and expressing an interest in getting more money into this fight. These are our children and the childhood of this nation is being destroyed by this epidemic. This cannot continue if we want to build a strong generation that's going to replace us. We must save that generation right now, and quite honestly, we're not doing it. I've heard politicians say they're one inch deep but a mile wide.



**Kevin:** They know a little bit of a whole lot of things, but they can't get into depth on anything. So, we need people to express to their representatives that this issue is important, and they need to pay attention to what Raven is saying.

Additionally, I am organizing a Human Trafficking and Cyber Investigations conference in June. We're building a collaboration between multiple states, multiple agencies, and non-profits. We're also bringing in prosecution and survivor services. Our goal is to pull them together in one location. We're looking at technology, after-care, and prosecution for this conference.
