The U.S. courts reported a <u>9% increase in authorized</u> <u>wiretaps</u>, and in 2025, these regional providers started receiving requests—first sporadically, then more frequently. The shift was noticeable, not just in volume but in urgency. The once-quiet corner of the organization responsible for compliance was now a critical touch-point in daily operations.

In a world where digital connectivity transcends borders, regulatory compliance remains firmly rooted in national boundaries, posing significant challenges for telecom service providers as they expand into global markets. As service providers globalize, they must navigate a rapidly evolving and increasingly complex regulatory environment. Minnesota became the 18<sup>th</sup> state to enact comprehensive consumer privacy legislation. On July 31, 2025, the Minnesota Consumer Data Privacy Act (MCDPA) went into effect.

In the European Union, the General Data Protection Regulation imposes strict rules on data handling, requiring service providers to implement robust privacy controls and obtain explicit user consent for data collection. India and Brazil are also tightening rules around lawful intercept, requiring service providers to build surveillance capabilities into their networks and cooperate with local law enforcement. These complex requirements often create legal and operational friction when building international infrastructure. Navigating these diverse and evolving frameworks requires deep regulatory expertise and agile compliance strategies—areas where Subsentio's global lawful intercept services offers valuable assistance and support.

Meanwhile, global telecom players are entering the U.S. market, bringing innovative technologies and competitive pricing. The U.S. regulatory environment is becoming more stringent, however, especially in the wake of recent cybersecurity breaches involving foreign actors, such as Salt Typhoon.

In January 2025, the Federal Communications Commission issued a landmark Declaratory Ruling clarifying that Section 105 of CALEA requires service providers to secure their networks from unlawful access or interception of communications. This ruling extends CALEA obligations beyond traditional surveillance capabilities to include proactive cybersecurity measures.

In this complex regulatory climate, Subsentio provides essential services to help service providers meet their legal obligations. Whether operating in the United States and expanding internationally or operating abroad and expanding into the U.S. market, we offer global solutions for lawful intercept, data retention, and records productions.
